



## .WED CONTEST RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. INTERNET ACCESS AND A VALID EMAIL ADDRESS IS REQUIRED. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED

ELIGIBILITY: Not open to employees, officers or directors (or to members of the immediate family or household of any employees, officers, or directors) of Atgron, Inc. ("Sponsor"), or any of its parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Contest promotion (collectively, the "Contest Entities"). Eligibility may be verified at any time. The .Wed Domain Name Giveaway (the "Contest") is subject to all applicable federal, state, and local laws and regulations. Void where prohibited. Any attempt by a person to enter more than the allowed number of entries, whether from the same email address or multiple email addresses or any other means, may result in disqualification. No illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. WINNER SELECTION AND NOTIFICATION: The winner(s) of the Contest will be determined on a first come first served basis throughout the Contest Period. The potential winner(s) will be notified by email using the contact information given at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within[3 days/72hours] after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected.
